Judah Vansyckel

Saluda Law, LLC Lexington, SC (Course Planner)

Admitted to the South Carolina Bar in 2010, Mr. VanSyckel's practice areas include Federal False Claims Act, Qui Tam, and whistleblower actions; and criminal defense matters, including white collar crime, financial crime, and fraud, as well as general criminal defense matters.

Mr. VanSyckel graduated in 2006 from the Honors College at the University of South Carolina, where he received a B.A with a double major in History and Political Science. He matriculated in the fall of 2007 at the Charleston School of Law, where he received his J.D. in 2010.

Prior to entering private practice, Mr. VanSyckel had the great fortune to work in government service and learn from more experienced attorneys. From August 2011 to April 2015, Mr. VanSyckel had the pleasure of working for the York County Public Defender's Office as an Assistant Public Defender. While there, Mr. VanSyckel handled a variety of matters in the various courts in York County, including the Circuit Court level General Sessions Court and the Magistrate and Municipal Courts in the county. He defended matters including exotic white-collar cases like insurance and securities fraud cases and 1st Amendment matters, and more general DUI, larceny, drug, and violent crime matters. While an Assistant Public Defender, Mr. VanSyckel tried over twenty cases to a jury verdict. Mr. VanSyckel is thankful for this start to his criminal law career.

In April 2015, Mr. VanSyckel joined the South Carolina Attorney General's office as an Assistant Attorney General. For most of his time, he worked in the Medicaid Fraud Control Unit where he investigated and prosecuted fraud committed by healthcare providers. As part of that position, Mr. VanSyckel also worked with the local U.S. Attorney's Office, the Columbia office of the Federal Bureau of Investigation, the local office of the Inspector General for the Department of Health and Human Services, and the local office of the Internal Revenue Service in the investigation of Federal criminal level prosecutions and Federal False Claims Act cases. Additionally, Mr. VanSyckel briefly spent time defending the State on Post-Conviction Relief claims. Subsequent to that he went into private practice.

Mr. VanSyckel is admitted in all the state courts of South Carolina and is also admitted to the Federal District Court for the District of South Carolina, the United States Court of Appeals for the Fourth Circuit, and the United States Supreme Court. Mr. VanSyckel is proud to be a criminal defense lawyer and to represent whistleblowers.

The Honorable William McKinnon

Circuit Court Judge York, SC

Judge William A. "Bill" McKinnon was born in Raleigh, North Carolina and is the son of Halbert H. and Gail T. McKinnon. His father is a dentist and a retired U.S. Army Reserve colonel, and his mother is a retired teacher. He is married to the former Ellen Whitley, a native of Rock Hill, and has two daughters, Bristol and Elspeth. His wife, Ellen, is a registered nurse.

Following his graduation from law school at South Carolina, Judge McKinnon clerked for then Chief Judge Joseph F. Anderson, Jr., in the District of South Carolina. He then moved to the Fairbanks, Alaska area for one year to clerk for the Hon. Andrew J. Kleinfeld on the United States Court of Appeals for the Ninth Circuit.

Judge McKinnon began his private practice of law with Covington & Burling in Washington, DC. He missed South Carolina, and came back in 2004 to join Lewis, Babcock & Hawkins in Columbia. At Lewis, Babcock, Judge McKinnon handled plaintiff's cases and defended civil cases. He subsequently moved to Rock Hill in 2007 to join McGowan, Hood & Felder, where he spent the majority of his career handling medical malpractice and other plaintiff's cases. He also occasionally represented other attorneys on ODC matters.

In 2015, Judge McKinnon began work as a part-time assistant solicitor in the Sixteenth Circuit Solicitor's Office while maintaining his private practice, and in 2016, went to work for the Solicitor's Office full-time.

Judge McKinnon was elected as a resident circuit judge in the Sixteenth Judicial Circuit in February 2018 and has served continuously since then.

Representative Micajah P. "Micah" Caskey, IV

Micah Caskey was born and raised in the small town of Springdale, South Carolina. He attended local public schools in Lexington 2 School District, grew up in McGregor Presbyterian Church, played sports all over town, and completed his Eagle Scout project at Harbison State Forest. The son of a small business owner, Micah started working long before he had a driver's license. Working in his father's locksmith shop taught Micah that nothing in life is free — everything worth having has to be earned. Hard work matters. That work ethic helped him earn a full scholarship to college.

After college, Micah spent the next several years on active duty in the Marine Corps — rising to the rank of Captain. Micah commanded both company- and platoon-sized units during his two combat tours of duty in Al Anbar Province, including Fallujah and Ramadi, Iraq. Later, in 2009, Micah left law school for a year to continue his service to the country; it was during that year that he commanded a small team of specialized Marines in Helmand Province, Afghanistan. Micah returned from Afghanistan and completed his law degree at the University of South Carolina. He also earned a master's degree in International Business Administration in the #1-ranked

international M.B.A. program at the University of South Carolina's Darla Moore School of Business. While in graduate school, Micah studied abroad in Europe and in Latin America, where he learned to speak Spanish. After graduating, Micah worked in an international firm as a management consultant in Alaska. In that capacity, he worked with Fortune 100 clients in the Oil & Gas industry to increase profitability and improve safety culture. Seeking a return home, he left Anchorage and Prudhoe Bay, Alaska, and returned to South Carolina to serve as a criminal prosecutor in South Carolina's 11th Judicial Circuit, based in Lexington Countty. In addition to his role there, Micah served statewide as a Special Assistant Attorney General, pro bono, to prosecute domestic violence cases. As a prosecutor, Micah prosecuted hundreds of cases, including several high-profile trials, as he handled all kinds of felony crimes — from drug trafficking to murder. In November 2016, Micah was elected to the South Carolina House of Representatives and was elected by his peers to lead the Freshman Caucus as its chairman. He was re-elected to the House in 2018, and again in 2020, where he continues to serve. He is currently assigned to the House Judiciary Committee and the House Ethics Committee. Micah also owns and operates a statewide private law practice, Caskey Law Firm, P.A., based in West Columbia. He is admitted to practice in the United States Supreme Court, the U.S. 4th Circuit Court of Appeals, the District Court for the District of South Carolina, and all South Carolina state courts. Micah has been honored to be able to represent District 89 in the state legislature, and he looks forward to the opportunity to continue to better the State of South Carolina.

Senator Gerald Malloy

SC Senate/Malloy Law Firm Hartsville, SC

Senator Gerald Malloy was born on October 26, 1961 and reared in Chesterfield County. After graduating from the University of South Carolina in 1984, he received his law degree from the University School of Law in 1988, and was admitted to practice law in the South Carolina Courts and the Federal Court. He moved to Hartsville to practice law, eventually establishing his own successful firm. In 2002, Malloy was elected to the South Carolina Senate, serving on the Senate Judiciary, Banking and Insurance, Education, Invitations, Rules, Transportation and Legislative Oversight Committees. He has served as the Chairman of the Sentencing Reform Oversight Study Committee since 2010 and is the co-chairman of the NCSL Law, Criminal Justice and Public Safety Committee.

He quickly established a reputation as a hard-working legislator who was willing to work across party lines to benefit his district and his state. He helped to establish the Butler Heritage Foundation, and received awards for his work in establishing and funding rural libraries. He is a past President of the South Carolina Trial Lawyers Association, past Chairman of the South Carolina Bar Association, and serves on the Board of Trustees for the Governor's School for Science and Mathematics. He is a life member of the University of South Carolina Letterman Association and also on the University of South Carolina Alumni Board. The South Carolina Commission on Indigent Defense presented him with the Distinguished Service Award in 2008 and has since renamed the honor the "Gerald Malloy Distinguished Service Award." His vocal support of law enforcement led to him being honored by the Fraternal Order of Police with the Legislator of the Year Award in 2010.

In 2016, Senator Malloy was the first legislator to receive the NACDL's Champion of State Criminal Justice Reform Award, recognizing individuals whose efforts have led to progressive reform of a state criminal justice system. The SC firefighters' Association inducted Senator Gerald Malloy into the Maltese Cross, a world-wide fellowship organization representing courage and loyalty to duty.

He is married to Davita McFarland Malloy and they have four children: Donovan, Jonathan, Jordan and Morgan. The Malloy Family attends Jerusalem Baptist Church in Hartsville, South Carolina. Senator Malloy serves on the Board of Trustees and is chairman of the Finance Committee.

Jimmy A. Richardson, II

Fifteenth Circuit Solicitor's Office Conway, SC

Jimmy Arthur Richardson, II was born and raised in Aynor, South Carolina. He is the son of Elise Gasque Richardson and the late Jimmy Arthur Richardson.

Jimmy received his Bachelor of Arts Degree in 1992 from the University of South Carolina – Coastal Campus. He graduated in 1997 from Regent University School of Law in Virginia.

After graduating from law school, he worked as the Judicial Law Clerk for the Honorable Circuit Court Judge Sidney T. Floyd, and in 1998 began work with the Fifteenth Circuit Solicitor's Office. As an Assistant Solicitor, he prosecuted criminal cases in all divisions of this office - Family Court, Magistrate Court, and General Sessions Court. While assigned to the General Sessions Division, he prosecuted a variety of serious felony cases, including murder, rape, burglary, armed robbery and drug trafficking. He also assisted in the successful prosecution of a murder case in which the defendant received the death penalty.

Judge Addy attended the public schools of Greenwood County, and upon graduating from high school, he enrolled in the Honors College at the University of South Carolina. While in college, he was nominated for Phi Beta Kappa. He graduated from USC cum laude in 1990 with a degree in International Studies and a minor in business. While attending USC law school, he served as Articles Editor for the Student Editorial Board of the Real Property, Probate and Trust Journal, was president of the International Law Society, served on the International Moot Court Team, and

was a member of the Palmetto Law Society. Judge Addy graduated from law school in 1993 and was admitted to the SC Bar on November 15, 1993.

Judge Addy began his legal career as Assistant Solicitor for the Eighth Circuit and was promoted to Deputy Solicitor in 1995. Upon the passing of his father in early 1997, Judge Addy entered the private practice of law while also assisting his grandparents in the family business. From 1998 to 1999, he served as Chief Public Defender for Greenwood and Abbeville Counties. He was appointed Greenwood County Probate Judge on June 3, 1999 and was subsequently reelected without opposition. In 2008, Judge Addy assisted in establishing the Eighth Circuit Drug Court.

He currently serves as treasurer for the South Carolina Circuit Judges Association, he is the Judicial Branch liaison to the Department of Mental Health, and in 2021 he was appointed as the Circuit Court representative to the Access to Justice Commission.
